

Suspect cholera case in city puts BBMP on alert

A 27-year-old woman from Malleswaram was admitted to a private hospital with symptoms of cholera, such as diarrhoea and vomiting.

The doctor who treated her in a private hospital found symptoms of cholera and informed the nearest city primary health centre. In the initial tests, there is a positive report about the presence of cholera, and the laboratory test (stool sample) throws up a negative report.

Officials also collected 10 water samples and sent them to the laboratory, however, no symptoms of cholera were reported in 165 households.

Palike also directed all hotels/restaurants/cafe owners to distribute hot drinking water to customers. All private hospitals under the corporation, private labs and government hospitals such as urban primary health centres, community health centres, taluk hospitals, general hospitals, hospitals under medical education should report all suspected cases in the IHIP database prescribed by the government.

Forced to attend Surya's rally, allege students

Students of Jain College, VV Puram, on Thursday alleged that they were forced to participate in a rally organised by BJP candidate Tejasvi Surya to file his nomination papers for Bangalore South Lok Sabha constituency.

Allegations were made on social media by the college students, which were later shared by activists. The clippings were from a Whatsapp group directing students to "compulsorily be present" there (rally).

The message, purportedly sent by the president of the students' council of the college, soon went viral, garnering over 121.6K views on X.

"Greetings members, Tomorrow all members of the student council have to assemble near Maiyas Hotel Jayanagar at 9am for the Tejasvi Surya rally. You'll be getting a T-Shirt so don't be late. Everyone has to be there at the reporting time and no excuses will be entertained. You will be getting attendance for this," read one of the screenshots.

When one of the students

questioned why their attendance at the rally was mandatory and said that being a part of political rallies was a personal choice, it was dismissed by the council representatives. The council responded saying they were "obliged" to show up at the rally.

"Before you guys get into all of this, I would like to tell you guys that at the time of our fest Tejasvi Surya was obliged by the student council to attend our fest, and now it's our turn to do the same. This is why it is compulsory for us to be there tomorrow as a council and

nothing else. Anyone else having any other questions regarding this rally can text me personally," continued the group conversation.

Reports said similar messages were also circulated in BMS College WhatsApp groups. However, while speaking to the media, the principal of Jain College refuted the claim for attendance.

Meanwhile, the Congress candidate for Bangalore South, Sowmya Reddy, urged the Election Commission of India to act on the matter immediately.

Painter held for rape, murder of beggar

Bengaluru: A 19-year-old painter has been arrested by the Amruthahalli police for reportedly raping and murdering a 55-year-old woman. The police have identified the accused as Sachin Ali Karan, a resident of Jakkur. The incident occurred around 8.30 pm on Tuesday. Sachin, who was consuming alcohol at a bar, saw the victim, who was a beggar, alone. He followed her and allegedly took her inside a building under construction, where he raped and murdered her. The woman's body was discovered by locals the next day. The victim, a native of Devadurga in Raichur, went missing on Tuesday, and her son kept searching for her. After finding his mother's body, he filed a complaint with the police, who managed to arrest the accused. Further investigations are on.

West Bengal man flees after killing wife

Bengaluru: A 35-year-old man from West Bengal is on the run after allegedly murdering his wife at their house near New Horizon Vidya Mandir in Bhoganhalli. The accused had allegedly murdered his wife by bludgeoning her head with a wooden plank. Hearing the victim scream for help, neighbours rushed to her house, and the accused managed to escape. The victim who was heavily bleeding from her head was shifted to hospital by the neighbours, but was declared brought dead. The victim has been identified as Banidebi Basak, from Nadia district in West Bengal. Her husband Jugal Basak is on the run. The couple worked as housekeepers. "According to neighbours, the couple frequently fought. On the day of the incident too, they had a quarrel. The accused is suspected to be an alcoholic," said an officer.

Woman on morning walk attacked, robbed

A 54-year-old woman was punched in her face and robbed of her gold ornaments by robbers in an auto on Brigade Millennium Road in JP Nagar Phase 7, early Tuesday morning. The incident happened between 5.15am and 5.30am, when R Vasantha was on her morning walk.

Of the gang, two got down from the auto and robbed her of her chain and started running towards the auto that was parked at a distance. The accused returned, punched her face when she tried to resist, and escaped in the auto. The attack left Vasantha with a completely broken tooth. With a bleeding mouth, she was taken to a police station by college students on their bike.

Vasantha, a resident of Navodaya Nagar in JP Nagar Phase 7, is a homemaker who

used to take the same route on her morning walk for the past five years.

"The victim's other teeth have also been damaged and need to be removed. The accused are said to have come from behind. One of them held her from behind, while the other accused pulled her gold chain. After they escaped, two students who were on their way to a nearby tuition centre brought her to the police station on their bike," said an officer.

After registering the complaint, Puttenahalli police rushed to the spot and checked CCTV footage in the vicinity, and are said to have obtained vital clues about the auto in which the accused fled.

Vasantha managed to see the face of one of the attackers. Police are in the process of showing her pictures of habitual robbers, hoping to get clues to the accused. Investigations are on.

ACTING on a PIL filed by a resident seeking directions to remove photographs of MLAs Priya Krishna of Govindaranjanagar constituency and his father M Krishnappa of Vijayanagar constituency from BBMP-owned public properties, parks, sports, play-

grounds, sports complex and 'dhanya mandira' situated in both the constituencies, the Karnataka High Court on Thursday issued notice to the state government and the Palike.

A division bench of Chief Justice NV Anjaria and Justice Krishna S Dixit issued notice to them after

hearing a petition filed by HM Arthish, a resident of Moodalapa, alleging that the authorities have failed to act on the matter despite he submitted the representations.

The petitioner has also prayed the court to issue directions to the state government and BBMP to comply with the di-

rections issued by the Supreme Court in 2016 and the High Court in 2021, about the removal of photos of public representatives from public projects, and take disciplinary action against delinquent officials. The inaction of the BBMP officials is benefitting the MLAs at the cost of public money, the petitioner alleged.
